1. *To Be Considered for the Award Nominee Must:*

- a. be a woman of at least eighteen (18) years of age who resides in Southwestern Connecticut;
- b. currently live in and own the home in which the room redesign would take place;
- c. be authorized to grant HER HAVEN, its contractors and volunteers, permission to enter and work in the home;
- d. have financial need as deemed by HER HAVEN;
- e. be inspiring, deserving and giving to her community;
- f. never have been convicted of a felony or a misdemeanor crime of domestic violence;
- g. agree to submit to a background check and to otherwise allow HER HAVEN to investigate and collect information in order to verify the accuracy of any and all information provided in this application and/or any media and/or materials submitted in connection with this application;
- h. agree to an in-home interview;
- i. agree to be photographed, videotaped or otherwise recorded, and consent to have her name, voice, image and likeness used by HER HAVEN without compensation or further notice for any lawful purpose whatsoever, including but not limited to, advertising, promotions, publicity, marketing, displays, or in any other manner, in any and all media now known or hereafter devised, worldwide in perpetuity; and
- j. agree and consent to the recording, reproduction, use and reuse by HER HAVEN of any and all information contained in, submitted with, derived from, or taken in connection with this application without compensation or further notice for any lawful purpose whatsoever, including but not limited to, advertising, promotions, publicity, marketing, displays, or in any other manner, in any and all media now known or hereafter devised, worldwide in perpetuity.

- c. make herself available at HER HAVEN'S request during the redesign process;
- d. work with HER HAVEN, its contractors and volunteers, including, but not limited to, participating at the conceptual stage of the redesign process;
- e. make sure that minor children and pets, if any, are kept safely away from the renovation area and/or have an authorized guardian or parent present while HER HAVEN, including, but not limited to, its designers, volunteers and/or contractors, is working in the home; and
- f. provide proof of homeowner's insurance, if requested.

However, if you should provide any media and/or materials simultaneously or contemporaneously with your application, you understand and agree that all such media and/or materials, and all intellectual property rights associated with such media and/or materials, become the sole property of HER HAVEN and may not be returned to you.

- B. Accuracy and Verification of Application Information. By signing below, I represent and warrant that all the information provided in this application is true and accurate. I understand, acknowledge and agree that if any of the information in this application is found to be false or incomplete, it will be grounds for denial of my nomination. I understand that any response I provide in my application is subject to verification by HER HAVEN.
